FCA US Hosts Vehicle Safety Training Best Practices Workshop

FCA US also engaged Company subject matter experts, legal counsel and external industry experts to develop a U.S. Safety Act Web-based Training Module, which was shared with workshop attendees.

In addition to this workshop, FCA US hosted the "First Automotive Safety Recall Best Practices Summit" on May 24-25, and co-hosted both the "2016 Advancing Safety Through Data Conference" on Oct. 6, as well as the " Second Automotive Safety Recall Best Practices Summit" on the Torrance, California, campus of American Honda Motor Co., Inc. on Nov. 17-18.
