Only nine percent of participating organizations were included in this year's "A" List. The results were published on October 25, 2016 in the CDP Global Climate Change Report "Out of the starting blocks: Tracking progress on corporate climate action," which tracks the recent progress of the world's largest listed companies.

Since 2012, FCA has been one of a limited number of companies that actively participate in all CDP initiatives (Climate Change, Water, Forest and Supply Chain).
