- Service at any Chrysler, Dodge, Jeep®, Ram, FIAT® or Alfa Romeo dealership
- Access to the latest diagnostic tools, factory-trained technicians and authentic Mopar® Parts
- Keeps recalls and RRTs up to date
- Cost of service contract may be capitalized with the cost of the vehicle
- Fleet vehicles may be serviced at independent repair facilities when an FCA US dealership is not available (i.e., remote locations)

Plus, Maximum Care and Added Care Plus Plans Include:

- \$100 "Sign-And-Go" Roadside Assistance (up to \$100 per occurrence)
- Rental Allowance (up to \$65 for 10 days)
- \$100 Tow Allowance
- Trip Interruption Coverage - up to \$1,200 maximum
- \$100 Transfer Fee (in most states)
- \$600 Key Fob Repair/Replacement Coverage

Reminder: Code vehicle orders with the correct Fleet Sales Code. If vehicles are taken out of stock to fulfill a VIP order, Fleet Operations home office must be notified to enroll the service contract.

Multiple Fleet VIP Plans for All Fleet Driving and Maintenance Needs

Choose Your Deductible and Mileage Intervals. All Fleet VIP plans are available with your choice of a deductible amount and are based on your expected mileage intervals. Depending on your plan, you'll pay your deductible (\$500, \$200 or \$0) of the total cost of covered component repairs performed during each visit ... the plan pays the rest!



FROM DELIVERY TO TOWING

Get Coverage for Most Vehicles in Your Fleet

Eligible Vehicles: Vehicles used for any commercial purpose and Cab & Chassis Applications within 36 months of the in-service date and 36,000 miles.

Commercial vehicle use includes but is not limited to:

- Delivery
- Landscaping/grounds maintenance
- Snow removal
- Service/repair work
- Shuttle service

Eligible modifications to vehicles include but are not limited to:

- Crane bodies
- Flat beds
- Box trucks
- Snowplow
- Vehicles with a mechanical apparatus used for hoisting/pulling or tow wrecked, disabled or stalled vehicles

Note: Usage must not exceed manufacturer's ratings and/or limitations.

Non-Eligible Vehicles: The following are **not** eligible for **any** Plan: Vehicles registered outside of the United States, Guam and Puerto Rico; motor homes; taxis; vehicles converted from two to four-wheel drive; vehicles altered or converted from the original manufacturer's specifications; severe off-road use; vehicles not used in accordance with manufacturer's specifications for payload and/or towing capacity; vehicles where the manufacturer warranty has been voided or restricted by the manufacturer; vehicles that have been declared to be a total loss by any insurance company, are rebuilt after being declared a total loss, or are issued a title indicating that the vehicle is designated as 'salvage', 'junk', 'rebuilt' or words of similar impact.

The following are **not** eligible for **this** Vehicle Protection Plan: Limousines; emergency vehicles (fire, police pursuit; police patrol); ambulance (except vehicles manufactured by FCA US LLC); vehicles used for security patrol; right-hand drive vehicles (except vehicles manufactured by FCA US LLC); vehicles used for postal service (except vehicles manufactured by FCA US LLC); vehicles used for dump truck (except vehicles manufactured by FCA US LLC); vehicles used for tow service (i.e., tow truck - except vehicles manufactured by FCA US LLC); vehicles equipped with a diesel engine (except vehicles manufactured by FCA US LLC, vehicles that operate on other than gasoline or diesel fuel systems (i.e., natural gas, electric); vehicles equipped with engines greater than 8 cylinders (except vehicles manufactured by FCA US LLC); one-ton vehicles used for commercial use (except vehicles manufactured by FCA US LLC); vehicles with a gross weight (G.V.W.) of over 14,000 pounds (except vehicles manufactured by FCA US LLC); ALL cab and chassis vehicles (except vehicles manufactured by FCA US LLC); vehicles ordered with box delete option or where the box has been removed (except vehicles manufactured by FCA US LLC); vehicles with dual rear wheels (except vehicles manufactured by FCA US LLC).
